

#### TOP OF MIND

#### Funding

On Tuesday March 26, 2024, the Hon. Peter Bethlenfalvy, Minister of Finance, tabled the 2024 <u>Ontario Budget</u>. Highlights of health sector investments include:

- An expected increase of 4% (\$965 million) in hospital base funding.
- Addressing health human resource challenges, including \$743 million to make permanent both the Extern Program and Supervised Practice Experience Partnership Program, increasing nursing enrolment and training programs, and \$50 million to help northern and rural communities attract and retain healthcare workers.
- Investments in primary care, including \$546 million over three years for primary care teams.
- Enhancing access to care for northern Ontarians through a \$45 million increase in the Northern Health Travel Grant program over three years.
- Over the next 10 years, investing \$50 billion into health infrastructure, including \$36 billion in capital grants and \$620 over 10 years to address urgent infrastructure renewal needs.
- A commitment to a new medical school with York University focused on family medicine.
- Investment of \$12 million to establish a new Health Technology Accelerator Fund, enabling healthcare service providers to purchase and leverage technology to enhance patient care.
- Unclear of what this looks like for HHS. More information to come over the next few weeks.

#### Accreditation

- Through the exceptional dedication and hard work of all staff, the HP&A OHT of HHS is a member, was awarded with Exemplary Standing from Accreditation Canada
- The redevelopment of the Mental Health Unit will begin shortly. This work is made
  possible through the All in Campaign by the AMGH Foundation and its generous donors
  - The project will consist of a new nursing station, medication room, observation room and patient dining area
  - All work will be issued through an RFP
- Ministry of Health will continue to provide hospitals with funding for the following health human resources programs.
  - Enhanced Extern Program (EEP):
    - Offers employment opportunities for qualifying nursing, medical, respiratory therapy, paramedic, physiotherapy, occupational therapy students, and Internationally Educated Nurses (IENs) to work in an unregulated capacity on paid assignments.
    - Through the 2024 Budget, the EEP has been made a permanent program.
       Funding will continue to be available to all publicly funded hospitals through Ontario Health.
  - Supervised Practice Experience Partnership (SPEP):
    - Provides eligible IENs with the opportunity to meet their evidence of practice and language proficiency requirements.
    - Funding for the SPEP program will also continue to be provided to all hospitals that are participating in the SPEP program who have been approved by the College of Nurses of Ontario (CNO).
  - Clinical Scholar Program (CSP):
    - Supports both recruitment and retention by creating mentorship opportunities. Through this program, experienced frontline nurses provide at-the-bedside mentorship and support to new graduate, internationally educated, or upskilling nurses to confidently transition into new health care working environments and nursing practice.
- Funding for the Clinical Scholar Program will continue to be made available to all publicly funded hospitals through Ontario Health.

The Huron Health System QIP aligns with our vision and strategic plan, as it focuses on:

 Better understanding how our ED LOS aligns with staffing levels and patient volumes over days of the week so we can ensure operational excellence.

- Ensuring staff training on diversity, equity and inclusion is monitored and encouraged.
- Educating our ED nursing staff on Sickle Cell disease presentation and management to empower our staff to be ready for changing demographics.
- Optimizing the feedback from our patients through updated questionnaires aligned with provincial reporting and pulling in key questions of the organization.
- Educating our nursing staff on the impact of delirium on patient outcomes, falls risk and the importance of routine screening. This will help us identify those showing signs of delirium as early as possible and treat it effectively. Thus empowering our people to deliver excellent care.

A very special thank you to Shari Sherwood for her hard work compiling the information and working with our teams to develop the plan and the metrics!!

Thank you once again for allowing me the opportunity to provide my perspective and thoughts as Chief of Staff at AMGH.

It has been another fun and interesting year working alongside Executive Director Kimberley Payne, the foundation staff and foundation Board. Over the last fiscal year, we have seen the completion of our secure room in the Emergency Department, necessary upgrades to the OR suites and are seeing movement through several phases of updates to the Mental Health Unit. In addition it has always been a privilege to be able to participate in some of the fundraising opportunities each year such as the <u>Badiothon</u> and Long Table Dinner. I think the highlight of the year for me was helping fundraise for what is effectively a bedpan/urinal dishwasher (The Tornado washer/disinfector) at the elegant and beautifully dignified setting of the Long Table Dinner. A close second, as always for me, is the ongoing presence and continual pop op in windows of those glowing blue hearts.

Speaking from a clinical and hospital level, we have come through yet another challenging year as health care resources remain strained and limited. # Financial Report -Audited Financial Statements

Before diving into the specifics of our financial position, I would like to express my gratitude to our dedicated Executive Director, our employees, board members and all stakeholders who have worked tirelessly throughout the year.

Your commitment and hard work are the backbone of the AMGH Foundation success, proving great local healthcare.

I am happy to report the foundation financial health, the foundations continues this year to be a sound financial position.

The accounts have been audited and the auditors report is attached in this package with full detail.

#### **Revenue:**

Our total revenue for the year was \$1,279,329 representing a 13% increase from the previous year

This growth was driven by general donations, in memory & investment income

TD Wealth generating \$177,755 in extra in come compared to last year \$67,732

#### **Expenses:**

- Our total expenses amounted to \$259,071 which is 25% increase from the previous year
- Major expenses included increase in salary expense, print & design & newsletter

#### **Profit/Loss:**

- We achieved a net profit of \$1,020,257 with is a 10% increase compared to last year
- This result was primarily due to having expenses within budget

#### **Cash Flow:**

- Our cash flow remain strong with closing balance of \$4,744,670
- This healthy cash flow allows us to support to the hospital future capital needs
- As of March 31st we have committed in spending \$3,006,008 to the hospital, with a remaining balance of \$1,735,662

I look forward to another year of growth for the Foundation.

#### MANAGEMENT'S RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

The accompanying financial statements of Alexandra Marine and General Hospital Foundation (the "Foundation") are the responsibility of the Foundation's management and have been prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO) of the Chartered Professional Accountants of Canada, as described in Note 1 to the financial statements.

The preparation of financial statements necessarily involves the use of estimates based on management's judgment, particularly when transactions affecting the current accounting period cannot be finalized with certainty until future periods.

The Foundation's management maintains a system of internal controls designed to provide reasonable assurance that assets are safeguarded from loss, transactions are properly authorized and recorded, and reliable information is available on a timely basis for preparation of the financial statements. These statements are monitored and evaluated by the Foundation's management. The Board of Directors meets with management and the external auditor to review the financial statements and discuss and significant financial reporting or internal control matters prior to their approval.

The financial statements have been audited by Seebach & Company, independent external auditors appointed by the Foundation. The accompanying Independent Auditor's Report outlines their responsibilities, the scope of their examination and their opinion on the Foundation's financial statements.

#### INDEPENDENT AUDITOR'S REPORT

To the Board of Governors and Members of the Alexandra Marine and General Hospital Foundation

#### Opinion

We have audited the accompanying financial statements of Alexandra Marine and General Hospital Foundation, which are comprised of the balance sheet as at March 31, 2024 and the statements of revenue and expenses and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the effects of the matter described in the *Basis for Qualified Opinion* section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of the Alexandra Marine and General Hospital Foundation as at March 31, 2024, and its financial performance and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

#### Basis for Qualified Opinion

In common with many charitable organizations, the Alexandra Marine and General Hospital Foundation derives revenue from donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the Alexandra Marine and General Hospital Foundation. Therefore, we were not able to determine whether any adjustments might be necessary to recorded fundraising and donations, excess of revenues over expenses, cash flows from operations, assets and fund balances. Our opinion on the financial statements for the year ended March 31, 2024, as well as the opinion on the prior year financial statements for the year ended March 31, 2023, was modified accordingly because of the possible effects of this scope limitation.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Alexandra Marine and General Hospital Foundation in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with ASNFPO, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Alexandra Marine and General Hospital Foundation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Alexandra Marine and General Hospital Foundation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Alexandra Marine and General Hospital Foundation's financial reporting process. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

  Hospital Foundation to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

#### NOTES TO FINANCIAL STATEMENTS

#### For the Year Ended March 31, 2024

#### 1. Incorporation

The Alexandra Marine and General Hospital Foundation ("Foundation") was incorporated under the Canada Corporations Act as a registered public foundation on December 14, 1993.

The purpose of the Foundation is to receive and maintain a fund or funds and to apply from time to time all or part thereof for charitable purposes carried on by, in connection with, in relation to, for the benefit of or to enhance or improve the services provided by the Alexandra Marine and General Hospital ("AMGH") and to do all such things as are incidental or conducive to the attainment of these objectives.

The financial statements of the Foundation are the representation of management prepared in accordance with Canadian accounting standards for not-for-profit organizations.

#### 2. Significant accounting policies

#### Basis of accounting

The financial statements have been prepared using the accrual method of accounting. Under the accrual method of accounting, revenue is recorded when earned and expenses are recorded when incurred.

#### Investments

The company has classified all stocks and bonds as available-for-sale which are carried at fair value. Bank guaranteed investment certificates are classified as held-to-maturity and are carried at amortized cost. A write down of the carrying value of held-to-maturity investments is charged against income when evidence indicates a permanent decline in the underlying value and earning power of an investment. Gains and losses on disposal of held-to-maturity investments are determined on a completed transaction basis.

#### 3. Investments

Investments consist of negotiable federal and provincial government securities and corporate bonds and equities as follows:

#### 4. Financial instruments

The Foundation's financial instruments consist of cash and investments. It is management's opinion that the Foundation is not exposed to significant interest and credit risks arising from these financial instruments. The fair value of the financial instruments approximates their carrying amount.

The Foundation's investment policy statement provides guidance on desired investment portfolio allocation ranges as follows: cash and short-term fixed income (10%-80%), longer-term fixed income (0%-50%), total cash equivalents and fixed income (60%-100%), and equities (0%-40%).

As the Executive Director of the Alexandra Marine and General Hospital Foundation, I am proud to present the annual report for the fiscal year 2023-2024. ## **Donations** and Fundraising Highlights

### Total Donations to Alexandra Marine and General Hospital

We are delighted to announce that the Foundation invested a remarkable total of \$1,458,394 in our hospital this year. This unprecedented level of generosity reflects the deep commitment of our donors to supporting the hospital's mission and ensuring high-quality healthcare for all.

#### Workplace Giving Program – new this year

- Purchase new medical equipment and technology
- Enhance patient care services
- Support staff training and development
- Improve hospital facilities

### Looking Ahead

Our Board is dedicated to self evaluation and improvement, working with MADJ Consultants, developing skills as a team that is prepared to meet the coming challenges our community hospital faces. - b) The Chair, while in the chair, is not disqualified from voting, except where there is a tie in the election of Directors, in which case the vote is lost.

#### 3.09 Corporation Annual Meeting Agenda

The business transacted at the Annual Meeting of the Corporation shall include:

- i. Minutes of the previous Annual Meeting;
- ii. Unfinished business from any previous meeting of the Corporation;
- iii. Report of the Chair of the Board;
- iv. Report of the Auditor;
- v. Report of the Executive Director
- vi. New business;
- vii. Other information or material relating to the Corporation's affairs as, in the opinion of the Directors, is of interest or importance;
- viii. Appointment of auditors for the ensuing year; and
- ix. Election of Directors.

#### 3.10 Fiscal Year

Unless otherwise determined by the Board of Directors, by resolution, the fiscal year end of the Corporation shall be March 31.

#### Part IV – The Board

#### 4.01 The Board

#### 4.01.1 Members of the Board

- a) The property and business of the Corporation shall be managed by a Board to a maximum of thirteen Directors. Twelve community members; and
- b) One appointed representative from the Alexandra Marine & General Hospital Board of Directors.
- c) New Directors to the Board will be considered after recommendation by the Governance and Recruitment Committee at the Annual General Meeting. Terms for all Directors will be determined at that time.
- d) At least one Alexandra Marine & General Hospital Foundation staff member and the Alexandra Marine & General Hospital President & CEO will be non-voting advisors of the

Board. These individuals will be expected to attend board meetings to provide information and guidance when called upon.

e) No employee of the Alexandra Marine & General Hospital Foundation or the Alexandra Marine & General Hospital can be a member of the Corporation.

#### 4.01.2 Qualifications of Directors

- a) Directors must be individuals who:
  - i. are not less than eighteen years of age;
  - ii. are not "incapable" as defined by the Act;
  - iii. do not have the status of a bankrupt;
  - iv. are not a non-resident of Canada within the meaning of the Income Tax Act of Canada.
- b) Directors shall serve as such without remuneration and no Director shall directly or indirectly receive any profit from his or her position as such; provided that a Director may be paid reasonable expenses incurred by such Director in the performance of such Director's duties. Nothing herein contained shall be construed to preclude any Director from serving the Corporation as an Officer or in any other capacity and receiving compensation therefor.

#### 4.01.3 Confidentiality

- Every Director and Officer of the Corporation and all Committee members shall adhere to the requirements outlined in the Foundation's Privacy Policies and sign a Foundation Confidentiality Agreement.
- b) Every Director and Officer of the Corporation shall respect the confidentiality of matters brought before the Board.

#### 4.01.4 Terms of the Board of Directors

- a) A Director is elected for a term of three years or for such shorter term (i.e. 1 year or 2 years) as determined at the Annual General Meeting and in consideration of expiry dates of terms for continuing Directors.
- b) A Director may not serve on the Board of Directors for more than two consecutive terms (6 years), but following an absence of one year, such person may be re-elected or reappointed.

#### 4.01.5 Vacancy/Removal of a Director

- a) The office of a Director shall be automatically vacated:
  - If such Director is absent without sufficient cause for more than three meetings of the Corporation during a Board year;
  - ii. If a Director has resigned their office by delivering a written resignation to the Chair of the Corporation;
